- 2. Bids received in the Mills County Judge's Office after the submission deadline shall be unopened and will be considered void and unacceptable. Mills County is not responsible for delayed mail, carriers, etc. and the time/date stamp clock used upon receipt of any bid in the county clerk's office shall be the official time of receipt. No fax bids or emails will be accepted.
- 3. Bids may be withdrawn at any time prior to the official opening. Alterations made before opening time must be initialed by a bidder guaranteeing authenticity. After the official opening, bids may not be amended, altered or withdrawn without the recommendation and approval of the Mills County Commissioners' Court.
- 4. The County reserves the right to accept or reject in part or in whole any bids submitted and to waive any technicalities related to the bidding process for the benefit of the County, granted that such waiver is allowed under federal and state law.
