This Regular meeting of the Mills County Commissioners Court opened in due form of law at 9:00 am in the Mills County Commissioners' Courtroom located at 1011 4<sup>th</sup> Street, Goldthwaite, Texas 76844.

Present in the Courtroom: Judge Jett Johnson, Commissioners Partin, Head, Williams, and Wright.

- 1. The Opening pledge of Allegiance was led by Judge Johnson and Prayer was provided by Commissioner Williams.
- 2. R & A on Minutes of May 13, 2024, and May 17, 2024: Commissioner Williams made the motion to approve the minutes as presented. Commissioner Wright 2<sup>nd</sup> the motion. Carried 5-0
- 3. There was no Audience with Individuals
- 4. C & A on approving Accounts Payable: Commissioner Williams made a motion to approve Accounts Payable, Judge Johnson 2<sup>nd</sup> the motion. Carried 5-0
- 5. C & A on Proclamation declaring June as Elder Abuse Awareness Month, Judge Johnson made the motion to declare June as Elder Abuse Awareness Month, Commissioner Wright 2<sup>nd</sup> the motion. Carried 5-0
- 6. C & A to appoint an ADA Compliance Officer. Human Resources or Treasurer normally holds this position. Commissioner Williams made the motion to appoint Treasurer Summer Campbell as Mills County ADA Compliance Officer. Commissioner Head 2<sup>nd</sup> the motion. Carried 5-0
- 7. Commissioner Request and Reports:
  - PCT 1: Commissioner Wright thanked the Clerk's Office for making sure that Road closures were updated and on the County Website and for all their work on the Election Run-Off. There is still a lot of damage from the rainstorms that pushed thru our area. County Roads 308, 327, and 313 are still closed for repairs.

PCT 2: Still trying to get roads repaired and noted that 312, 250, and 235 are still closed.

PCT 3: All County Roads in PCT 3 are open, however some may be rough driving.

- PCT 4: CR 508 is open but with expected rain in the forecast it may not be open for long. CR 417 still closed. There is a lot of tree damage.

  Noted that there is an email from FEMA on reports that need to be filled out.

  Also bought some more traffic cones that will be divided equally among the precincts to mark road damage.
- 8. County Judge's Report: Made aware that Congressman Pfluger will be at the Mabank Community Room. As of 2/25/2024 the basement of the Court House was restored to pre-flood dry standards. There is still the issue of asbestos removal and Guy Burns is talking to the Historical Commission on how that needs to be done.
